How to Enter the Juried Show

- ✓ Submit up to four images per submission to be juried: only digital images on CD or DVD will be accepted.
- ✓ You may submit more than one entry; use one of the attached submission forms with each entry.
- ✓ Send or deliver completed submission form, entry fee and submitted images to Image City Photography Gallery postmarked **by August 5, 2011**.
- ✓ Entry fee is \$10 per entry before July 15 and \$15 after July 15 by credit card or check payable to Image City Photography Gallery. **Final day of submission is August 5, 2011**

Submission for Jurying Digital Images

- ✓ The Image City Curatorial Committee will make the final selection.
- ✓ Digital image must be submitted as JPEGs on a CD or DVD and must be 100- dpi in finished size of at least 7 inches in longest dimension. Emailed images will not be accepted.
- ✓ Deliver or mail submissions to Image City. Entry must be postmarked by August 5, 2011
- ✓ Submitted CD's or DVD's are not usually returned. But, if you wish they may be picked up at The Gallery between the opening of the show through August 26, 2011.

Conditions of Entry

- ✓ The submitted images must have an element of photographic origin.
- ✓ All entries must be of original design and personal execution.
- ✓ All entries must be taken on a Cell Phone.
- ✓ All manipulation of images must be done on the Cell Phone. Any image discovered to be manipulated on a computer will be disqualified.
- ✓ Accepted work may not be withdrawn before the close of the exhibition on October 30, 2011.
- ✓ Image City will retain a 30% commission on all sales made during the exhibition.

Exhibit Prints -accepted works (not submissions for jurying)

- ✓ Print size, the size of the paper the image is on, must be no bigger than 100 sq. inches. The actual image can be any size on the paper
- ✓ No images are to be framed or matted.
- ✓ All images must be printed on photographic paper
- ✓ The curatorial committee and Image City reserve the right to refuse any entry if the quality of the work was not accurately represented in the submitted image.
- ✓ Please contact Image City with any questions about the presentation for your accepted photograph(s).
- ✓ All images will be for sale unless told otherwise by the photographer.
- ✓ All images will be sold for \$30.00. Image City will retain a 30% commission on all sales made during the exhibition.

Liability / Delivery / Retrieval

- ✓ All accepted photographs must arrive at the Gallery between September 21 thru September 24, 2011 Gallery hours: Wednesday - Saturday, 11 am - 7 pm, Sunday, noon - 4 pm.
- ✓ Artists are responsible for all shipping costs including insurance. Work must be shipped in a substantial, reusable container. The Gallery will not be responsible for any damage that occurs during shipping.
- ✓ Prompt retrieval of photographs after the exhibit will be gratefully appreciated. Photographs should be picked up October 30, 2011 from 4 - 7 pm. If not picked up at the Gallery, arrangements for packaging and shipping photographs are the responsibility of the photographer.

Notification of Acceptance

- ✓ Letters of acceptance will be mailed by August 26, 2011.
